21	This document is confusing because it combines Plaintiffs' arguments and disagreements with		
22	Defendants previous discovery responses, requests for Court orders compelling answers, and requests		
23	for clarification, and new discovery requests. Defendants object to this filing in its entirety for four		
24	reasons:		
25	1) Plaintiffs should send additional disco	overy requests to Defendants and not file them with the

27	Court. U. Dist. Ct. R. 4.		

- 2) To the extent Plaintiffs are moving to compel answers, they have not complied with Mont. R. Civ. P. 37 and have not in good faith conferred or attempted to confer with Defendants regarding Defendants' so-called failures to answer.
- 3) Plaintiffs' filing contains large amounts of argument over the meaning of various GLA governing documents and disagreement about Defendants' previous answers which are not the proper subject of these additional discovery requests and motion to compel.
- 4) Plaintiffs also appear to be complaining that Defendants did not create entirely new documents or summaries of existing information in response to their requests. The Montana Rules of Civil Procedure do not require the creation of new documents in response to requests for production but only that responsive documents in the respondent's possession be produced. Defendants have produced existing responsive documents which contain the information requested, and it is Plaintiffs' responsibility to read the documents.

<u>DISCOVERY REQUEST NO. 1 & 14:</u> For clarification, Plaintiffs ask if the Defendants verified if any of the members proxies listed below were valid? Plaintiffs ask if the Defendants notified any of the following members listed below to let them know that their proxies can not[sic] be given to Directors? **RESPONSE:** 

For clarification, Plaintiffs ask if the Defendants verified if any of the members proxies listed below were valid?

Response: Defendants are not sure what Plaintiffs mean by the term "verified" which is not defined by Mont. Code Ann. § 35-1-535(2). However, when Defendants receive proxy forms for an upcoming election it is checked to make sure it is signed and the signer is allowed to vote and thus give a proxy.

Plaintiffs ask if the Defendants notified any of the following members listed below to let them know that their proxies can not[sic] be given to Directors?

Response: Members were not allowed to designate the Board or Directors as proxies starting with the election held in November of 2012. The proxy form for that election stated this so members were informed their proxies cannot be given to Directors or to the Board.

**DISCOVERY REQUEST NO. 2:** Defendants failed to identify committee type as either a "committee of directors" or else an "advisory committee" as discovery request #2 (cited above) required.

**RESPONSE:** Defendants have provided a list of current committees and their members. As can be seen from the listed members each of these committees is a Committee of Directors except for the Road and Weed Subcommittee which is advisory. Further information about committees is contained within the meeting minutes which were also produced to Plaintiffs.

DISCOVERY REQUEST NOS. 3 & 13: Plaintiffs request clarification of this answer by asking

Defendants do so called "cost of labor and material" include the costs of labor to research and find such
documents? Also determine how much money is "reasonable costs of labor and material" to provide
one page of the Aug. 2011 GLA minutes? Do the Defendants have a fee amount per page?

Also is Rich Spalone an owner of R&B builders as paid certain fees by the GLA? Was or is

Alyssa Allen an owner of "Angelis Design" as paid certain fees by the GLA? Was or is Sandra Irby an

owner of "Irby Enterprises" as paid certain fees by the GLA? Did Sandra Irby and James Gough collect

and/or count ballots for 2011 GLA Board election?. and for 2010 also?

### **RESPONSE:**

Plaintiffs request clarification of this answer by asking Defendants do so called "cost of labor and material" include the costs of labor to research and find such documents? Also determine how

much money is "reasonable costs of labor and material" to provide one page of the Aug. 2011 GLA minutes? Do the Defendants have a fee amount per page?

Response: Costs of labor includes the time and effort necessary to locate and compile the requested documents. Defendants do not know what the reasonable costs of labor and material is to provide one page of the Aug. 2011 GLA minutes as such a thing has never been requested. The fee per page for material is ten cents per page. Labor costs are charged at \$20 per hour, prorated.

Also is Rich Spalone an owner of R&B builders as paid certain fees by the GLA? Was or is

Alyssa Allen an owner of "Angelis Design" as paid certain fees by the GLA? Was or is Sandra Irby an

owner of "Irby Enterprises" as paid certain fees by the GLA? Did Sandra Irby and James Gough collect

and/or count ballots for 2011 GLA Board election? and for 2010 also?

Response: To Defendants' knowledge and belief, Rich Spallone is an owner of R&B Builders.

Alyssa Allen is an independent contractor doing business as Angelis Design. Sandra Irby is an owner of Irby Enterprises. Sandra Irby, James Gough, and other volunteers counted ballots at the GLA election in November of 2011. Neither Sandra Irby nor James Gough counted ballots in the 2010 election.

DISCOVERY REQUEST NOS. 4 & 5: Defendants failed to include any audit documents since 2010 and failed to "otherwise state no audits were done." The Court should order Defendants to do so, for Defendants failure to object otherwise to this request. Also the GLA admits it denied members "2010 receipts and expenditures." Plaintiffs request clarification as to why Defendants denied its members a copy of the "2010 receipts and expenditures."

Defendants also claim "it gave all GLA members a copy of GLA receipts and expenditures for the fiscal years 2011 and 2012 by mail." Plaintiffs request clarification as to if documents 000182 through 000194 are the same "receipts and expenditures...2011 and 2012" allegedly provided its members 2011 & 2012 and what were the exact dates the documents were mailed to all members?

Also for clarification, answer yea or ney to 1-4 the GLA Board decided 1. "check details" were

NOT to be part of the "receipts and expenditures" mailed to members? And decided 2. "deposit

details" were NOT part of the "receipts and "expenditures" mailed to all members? and decided 3.

"cancelled checks" were NOT part of the "receipts and expenditures" mailed to all members? and

decided 4. "credit card & bank statements" were NOT part of the "receipts and expenditures" mailed to

all members? Also has the GLA ever told all its members that any of these other documents 1-4 above

are available to them upon requests? If so, provide written proof of such notice to all members.

### **RESPONSE:**

Defendants failed to include any audit documents since 2010 and failed to "otherwise state no audits were done." The Court should order Defendants to do so, for Defendants failure to object otherwise to this request. Also the GLA admits it denied members "2010 receipts and expenditures." Plaintiffs request clarification as to why Defendants denied its members a copy of the "2010 receipts and expenditures."

Response: To the extent this "request" is for an Order from the Court compelling answers,

Defendants object on the basis that they fully provided good faith answers to Plaintiffs' previous

discovery requests. There are no audit documents since 2010 and therefore, obviously, no audits were

done. As a practice, various financial documents were provided at the annual meetings. A document

titled "Receipts and Expenditures" was not compiled but the information was otherwise provided in

other documents. Starting in 2011 this information was compiled into a document titled "Receipts and

Expenditures" which was mailed out to members.

Defendants also claim "it gave all GLA members a copy of GLA receipts and expenditures for the fiscal years 2011 and 2012 by mail." Plaintiffs request clarification as to if documents 000182

through 000194 are the same "receipts and expenditures...2011 and 2012" allegedly provided its members 2011 & 2012 and what were the exact dates the documents were mailed to all members?

Response: Document 000186 – 000190 is the Receipt and Expenditure report for 2011 which was mailed to members approximately October 10, 2012. Document 000191 – 000194 is the Receipt and Expenditure report for 2012 which was mailed to members approximately January 18, 2013.

Also for clarification, answer yea or ney to 1-4 the GLA Board decided 1. "check details" were NOT to be part of the "receipts and expenditures" mailed to members? And decided 2. "deposit details" were NOT part of the "receipts and "expenditures" mailed to all members? and decided 3. "cancelled checks" were NOT part of the "receipts and expenditures" mailed to all members? and decided 4. "credit card & bank statements" were NOT part of the "receipts and expenditures" mailed to all members?

Response: As to "answer yea or ney to 1-4" above, the Receipts and Expenditures report is a general report that does not contain check details, deposit checks, cancelled checks, credit card and bank statements. The GLA did not specifically discuss whether or not to include this information in the report so it cannot truthfully admit or deny it "decided" whether or not to include these items in the Receipts and Expenditures report. However, the report was produced following generally accepted accounting practices to show the overall receipts and expenditures of the GLA and thus did not break down totals according to the detailed information Plaintiffs are asking about.

Also has the GLA ever told all its members that any of these other documents 1-4 above are available to them upon requests? If so, provide written proof of such notice to all members.

Response: The GLA has informed its members such documents are available through its Bylaws which state: "The financial reports and Membership records of the Association shall be available at

the principal office of the Association for inspection at reasonable times by any Member." Article VIII.I.

DISCOVERY REQUEST NOS. 6 AND 9: The Court should order Defendants to provide requested answer & documents for this issue unjustly denied Plaintiffs. This is because, Defendants have completely denied this request for an answer to this request and denied all documents above relevant to these two claims, and denial of such discovery negatively prejudices Plaintiffs claims for these matters. RESPONSE: This "request" is not a discovery request to Defendants but rather a request to the Court to order Defendants to answer previous discovery requests that Defendants have objected to. Those requests involve information related to the "Erickson Project" which was an issue decided by Judge Gilbert in another case. As such, Plaintiffs have improperly brought that same issue before this Court knowing that Judge Gilbert already decided the issue. Further, Plaintiffs are appealing Judge Gilbert's decisions, making their continuing to try and litigate the issue in this Court all the more improper. DISCOVERY REQUEST NO. 7: After this lawsuit was filed June 2011 requesting such vote tallies, GLA Defendants now respond that since 2011, it started to publish GLA election vote tallies in the GLA newsletter. Plaintiffs request copies of ALL GLA newsletters since 2011 to verify this response. RESPONSE: See GLA newsletters since 2011 produced and bates stamped as documents 000479 -487.

by answering if maintaining GLA roads, snowplowing, and "managing" the GLA are services required by the Association Directors, per covenat [sic] 11.02 that says, "assessments...shall be used for the operation, maintenance, repair and improvement of roads, ...for snowplowing;,,,[sic] and for such other uses and purposes which are contemplated in these covenants."

Also without objection, Defendants failed to provide any written bids as requested, and failed to provide job duties, authorities, and amount of payments for every GLA agents, employees, contractor & Director paid with GLA monies. Plaintiffs thus ask the Court to require the GLA to provide such documents and also state no written bids exists.

### RESPONSE:

Plaintiffs request clarification of Defendants response to this issue by answering if maintaining GLA roads, snowplowing, and "managing" the GLA are services required by the Association Directors, per covenat [sic] 11.02 that says, "assessments...shall be used for the operation, maintenance, repair and improvement of roads, ...for snowplowing;,,,[sic] and for such other uses and purposes which are contemplated in these covenants."

Response: Assessments are used in accordance with the entirety of section 11.02 of the GLA Covenants and not just the portion quoted by Plaintiffs.

Also without objection, Defendants failed to provide any written bids as requested, and failed to provide job duties, authorities, and amount of payments for every GLA agents, employees, contractor & Director paid with GLA monies. Plaintiffs thus ask the Court to require the GLA to provide such documents and also state no written bids exists.

Response: Plaintiffs ask the Court to order Defendants to produce documents allegedly not produced. Plaintiffs wrongfully assume documents were withheld. Defendants produced documents responsive to the original request as documents 000359-395 and 000433-465 which include check details, expenses by vendor details, contracts outlining duties to be performed, and bids. Defendants will not state no written bids exist because they do exist and were produced as documents 000464 and 000465. Previously produced meeting minutes (documents 00031 -141) also contain this information which Plaintiffs can read for themselves.

<u>DISCOVERY REQUEST NOS. 10 & 11:</u> But this Masterplan 7.01 above clearly shows GLA members have rights to the property adjacent to Ericksons that <u>the Association does NOT have exclusive rights to this property</u>, for which all members own this Association & property. Therefore Defendants admit all member were not contacts, but should have been contacted for the Erickson project review adjacent to their property, especially since the Erickson "finding of facts" specifically mentions members common use property.

RESPONSE: This is not a discovery request. This is simply Plaintiffs trying to argue the merits of their case and disagreeing with Defendants original answer. This argument is improperly before the Court.

DISCOVERY REQUEST NO. 12: Actually the GLA Defendants have misled the Court to say they use Roberts rules [sic] of Order and that the GLA President votes, since Roberts rules [sic] of Order attached to the Complaint says the GLA President does not vote except to break a tie vote. However Defendants already admitted in the DV-11-193 settlement agreement that the GLA President should not be barred from voting.

**RESPONSE:** Again, this "request" contains no actual requests, but is simply Plaintiffs' arguing over a previously given answer. Defendants have not misled the Court, and Plaintiffs' argument is nonsensical and should be ignored.

<u>DISCOVERY REQUEST NO. 14:</u> Plaintiffs request a corrected membership list that includes all email AND also phone contacts that GLA members have voluntarily given to the GLA; and should denote who is eligible to vote based on if they paid assessments in full.

**RESPONSE:** Defendants have previously provided a membership list containing the information required by Mont. Code Ann. § 35-2-906(3) as documents 000466-478. Defendants stand on their objection to producing email addresses. Plaintiffs now request phone numbers, and Defendants object to producing phone numbers on the same basis as its objection to producing email addresses. Plaintiffs will

simply use this information to continue to harass other GLA members. Further, producing that information would violate members' right to privacy.

Defendants are unable to provide a complete list of who is eligible to vote at this time as every member is potentially eligible to vote. For example, Plaintiffs own property within the GLA and are thus potentially eligible to vote at the upcoming annual election. If Plaintiffs were to sell their property before the election they would no longer be eligible to vote. Similarly, if Plaintiffs did not pay their complete assessment by election day, then they would not be eligible to vote. Currently, every member of the GLA is potentially eligible to vote, but a final determination of eligibility is not made until right before the election. Attached and numbered 000488 through 000500 is a list of members denoting whether or not they are current on their assessments. This list provides the best prediction of who will be eligible to vote in the 2013 annual election.

### Budget: On Track & Still in the Black!

Having just weathered the second most severe snowstorm in Montana's recorded history for November, we are once again giving more attention to road conditions, winter driving, and safety in this edition of our Newsletter.

We want to let Landowners know that although the 2010 road budget was stretched beyond its limits due to the storm, we were still able to stay within our annual budget for the year and remain in the black! This is remarkable, considering that so many outside contractors had to be brought in, and resources stretched to their limits. This was also the case for all of Park County, as our local government struggled to handle what nature dealt us, putting the County over in their road budget for the year as well.

We thought we were in good shape in November with \$3,000 remaining in the snowplow budget, having used only \$1,000 for the entire year. But with this one storm costing us over \$12,000, it put us at \$13,000 just in snow removal alone. Although this was \$9,000 over our snowplow budget, we had enough remaining in other budget areas to cover this unexpected expense.

Since this has depleted our reserves, the Board is looking at the possibility of having to do a special assessment to cover these unusual costs. As an example, a special assessment of \$10,000, would equate to only \$26 per owner. We will be discussing this further at the *Emergency Preparedness Meeting*.

### Help Keep Your Assessments Low

Compared to other homeowner associations, our assessments are still extremely low by current standards, especially considering the huge cost of maintaining a 22-mile road system with its varied terrain. Our assessments equate to little more than one dollar per day for each homeowner. Also, keep in mind the limitations of what we are capable of doing as a volunteer organization.

Though the cost of maintaining the roads and the general cost of doing business continues to rise, the Board has determined that due to the continued state of the economy, annual assessments will not be raised this year.

Each year our road expenses take up over 70% of our annual budget, but with the November 2010 snowstorm and fall grading, road expenses were over 81%. The extensive volunteer hours put in by

Board members have allowed us to operate without a manager, an office, or any full-time employees. This practice has left us with enough money in our 2010 budget to absorb the recent snowstorm expenses.

As the Board continues to work to keep the cost of operations low in the coming year, when making a request for increased services, owners should consider whether they are also willing to increase their assessments to provide for a greater level of service.

### Winter Snowstorm Report

Thanksgiving Headline in the Livingston Enterprise reads: "Winter Snowstorm Hammers Park County"

What began like a "normal" winter storm quickly turned into a full-blown blizzard, dumping up to 32 inches of snow and leaving five to six foot snowdrifts in its wake, with some as high as eight feet in the upper elevations! "Emergency Only" travel advisories were issued throughout the County. Schools were closed (which rarely happens here) and temperatures dropped below freezing with high winds and extreme wind-chill factors for more than a week.

Our snowplow trucks battled heavy snow for several days. Before the storm reached its peak on Thanksgiving Day, it became apparent that our little snowplows were no match for Mother Nature's fury. Our normal snow removal equipment was unable to move long, deep stretches of drifted snow and larger, heavy-duty equipment had to be

brought in. During the height of this extreme weather we hired as many as nine rigs and operators to work on clearing our roads—some working several days around the clock through freezing nights and high winds. There were also individual owners with their own equipment who pitched in to help.

When the snow finished falling and the wind abated, and after enormous effort in man and machinery-power, we were finally able to clear a single lane through the entrances of North and South Glastonbury. More effort and time was needed before we were able to clear both lanes and secondary and tertiary roads.

We learned early on that the entire County was dealing with the same difficulties, with many roads in town closed, and the County also having to hire outside

contractors to help in the effort to clear snow. With the unexpected cost of clearing roads, it was reported that the County Commissioners were considering declaring a State of Emergency that would allow the County to collect a special tax to cover the additional costs. Fortunately, this step was not taken.

We also learned that during the Thanksgiving storm, snow and ice, combined with high winds, reduced visibility so drastically that there were 40 vehicle slide-offs reported in the County. Similarly, we had many vehicles here in Glastonbury that needed to be pulled out from drifts along the roads, with some cars even stranded in the middle of the road for days.

The basic message that the Sherriff's Department sent out was "if you're warm and safe where you are, and it's not an emergency, stay there." We echoed the same message here until we knew it was fairly safe for owners to travel on the roads.


Considering the intensity of the storm, we were extremely fortunate that the Road Committee was able to swiftly mobilize the manpower and heavy equipment needed to deal with these unusual conditions. Within a few days our roads were in better shape than many

county and city roads. We also witnessed a wonderful spirit of cooperation from community members in assisting their neighbors, and some even coming to the rescue on snowmobile for those in need.

We are very grateful to our road crews for their efforts and willingness to work such long hours through the night on a holiday weekend when they certainly would have preferred to be home with family. Special thanks to Rich Spallone, Paul Rantallo, Ed Dowbrowski, Pouwell Gelderloos, Darrel

Windorski, John Fanuzzi, Mike Adkins, Hank Fabich, Steve Sirois, John Hazen, all of our wonderful neighbors, and the many unsung heroes who volunteered their help. We would also like to thank William Smith, Kay Spallone, Glenda Rantallo, and Laura Boise for their efforts throughout the week of the storm in coordinating and keeping communication with the road crews, receiving and relaying reports of incidents, sending out telephone trees, and taking calls to assist Owners as well as their renters.

It is gratifying to know that we live in such a wonderful community where people work together to help one another. We hope that the following articles will provide you with information that will help you to "weather the storms" of the future, and assist you in having and safe New Year.



## GLA Snowplowing Policy

GLA roads are plowed according to what our limited resources allow, and please keep in mind that we do not have any full-time employees. The plowing of individual subdivision roads is the responsibility of each subdivision and these are not cleared by the GLA. You may refer to the GLA's Road Policy to know what level of snowplowing service you can reasonably expect in your area. If you do not have a copy of the GLA Road Policy, you may request a copy by leaving a message on the GLA answering service at 451-0033 and a copy will be mailed to you.

<u>Tier 1:</u> Main Roads in the Flat and Lower Hilly Areas are given first priority since they serve as main arteries to other roads.

<u>Tier 2:</u> Secondary Roads in Lower Areas are cleared next, as they are the second most used roads by a large number of owners.

<u>Tier 3:</u> Tertiary Roads are cleared next. These are in mid to high elevations, and travelled by fewer owners.

<u>Tier 4:</u> These roads are cleared last. They are in the highest elevations, have the most difficult terrain, and service very few owners.

You may also leave a phone message for the Road Committee by calling our automated answering service

at 451-0033. Please refrain from contacting members of the Road Committee directly *unless it is a road emergency*. By contacting them unnecessarily on their personal lines, it diminishes their ability to get the roads cleared. For any other emergencies, call 911.

# \* Emergency Preparedness Meeting \*

January 26, 6:30 pm at St. John's Church

After reflecting on how the community as a whole was prepared to deal with the recent emergency conditions, the Board decided to establish an Emergency Preparedness Committee to assist owners in becoming more prepared. To this end, we are offering some basic lists in this Newsletter to help prepare for simple emergencies. We also urge as many owners as possible to attend this important meeting.

During the storm, many owners were unprepared for such extreme weather, both in their cars and in their homes. Being snowed-in from time to time is to be expected in rural mountain areas of Montana during late fall and winter.

We are thankful to report that everyone made it through the storm safely, although we had a few narrow escapes, with one mother-to-be's due date right at the height of the storm, and an elderly woman who was out walking required help to get home.

We are aware that some Owners have illnesses requiring medication or could need emergency medical attention. For future reference, please be aware that if the roads are impassible during an emergency, you can call 911 and they will dispatch a County snowplow to clear the way ahead of the emergency vehicle.

One problem experienced by many Owners was that even after the community roads were cleared, they were unable to get out of their own driveways for many days. By now, most Owners have learned who they can contact to get help with their personal snow removal needs, but it may be beneficial to coordinate efforts with neighbors to bring a contractor to your area.

While the crisis created by the storm is still fresh in our minds, and being aware that extreme storm patterns have been more frequently occurring from coast to coast and across the world, now is a good time for each of us to evaluate our personal needs. Although we cannot control the extremes of weather, we can plan for, and become better prepared to handle them.

In considering what might be needed for a future emergency, it is helpful to recall situations that have occurred in our own area in recent years.

Last year a power outage from high winds left many without electricity, light, water or heat, and no way to cook food for an extended length of time. Although in recent years we have had extremely mild winters, the mid-eighties brought a severe winter storm leaving us in arctic conditions with extreme sub-zero temperatures for over two weeks. A few years ago a forest fire swept through the high South area, burning down one home and threatening others. Many Owners were evacuated and certain roads were closed off. Two years ago unusual torrential rains washed out several areas of our roads taking days to repair. Last year a vehicle slide-off on a near-by county road, in extremely cold weather, resulted in a loss of life.

Because we were able to clear our roads shortly after the November storm, we were more fortunate than many in other rural parts of the County who were snowed-in for days. Although we feel good about the job we did during this extremely challenging storm, we are looking at how we can plan for future emergencies.

One way the GLA hopes to assist Landowners with safety is to work toward developing greater cohesion in our community this year. Within each neighborhood area we plan to develop a system where neighbors can check in with each other including the elderly, or help a neighbor in need. If you are interested in assisting in this effort, please attend the January 26th meeting.

We would also like to see all Landowners and their renters who live here sign up on the GLA Telephone Tree in order to receive timely announcements. (Details below.) Additionally, we are planning to utilize the GLA answering and e-mail messaging systems for contacting owners in the future. This will ensure that no one is overlooked should an emergency situation arise again.

### Sign Up for the GLA Telephone Tree

A big thank-you to our good neighbor, Maydell Goulart, for setting up a special Telephone Tree service specifically for GLA Landowners and their renters.

These Tree messages generated by the GLA were an immense help during the recent storm. Many Owners were grateful to receive these messages that provided them with daily updates of the road conditions.

This was an extremely critical service in a situation where even some of the main roads and highways throughout many parts of the County became impassible. Because some Owners were not a part of this messaging service, they were unaware of the severe road conditions. As a result of going out on the roads, some became stuck or stranded. Others abandoned their cars along the road, making it more difficult for our road crews to clear the roads.

We highly recommend that all Owners sign up for this special free community service. This can assist us in the future as a way to provide timely notification to those on the Tree for emergencies, as well as other GLA announcements.

### Winter Driving in Montana

Mountain terrain combined with snow and ice creates hazardous conditions for driving and requires extra alertness and good judgment in order to avoid accidents or becoming stranded. Slick roads require that we drive slowly and maintain a greater distance when following another vehicle. Sudden braking can cause skidding, which is why slower speeds are recommended, especially when we live in an area with deer and other wildlife crossing the roads.

Should you find yourself stuck in the snow, remember that it is often safer to stay in your car, call for assistance, and wait for help. Getting out of your car to attempt to dig yourself out in severe weather can quickly use up vital energy needed to stay alive. This also may create greater exposure to hypothermia or frostbite. Please consider what you would need to have in your car to ensure you could survive in this situation if it were extremely cold.

### Recommended to Have in Your Car

- · Warm Hat and Extra Gloves & Liners
- Blanket or Sleeping Bag
- Extra Coat in Vehicle
- Small Shovel
- Flashlight
- Flares
- · Cell Phone
- Water Bottles
- Snacks for Energy
- · Instant Hand and Feet Warmers (small packets)

### Recommended to Have in Your Home

- · At least one week of food and water
- Dry food that needs no electricity for preparation
- Large 5 gallon water bottles (during electric outage)
- Flashlights, candles, matches, and extra batteries
- Cell phone or land-line phone not requiring electricity
- Solar or propane stove for cooking/boiling water
- Solar or propane lantern and extra fuel
- · Comprehensive first aid kit
- Short wave or CB radio
- Power generator and fuel

### Community Prepares for Winter

In anticipation of another potentially harsh winter, our community has been preparing well in advance by readying snow removal equipment, putting up snow fencing, holding preparedness meetings, and establishing ways of communicating with each other for road condition updates.

As a primary response, the GLA has hired part-time employees to drive the GLA snowplow trucks, thereby ensuring that our roads will be cleared in the most timely way possible. In addition, we may use snow removal contractors with the appropriate equipment. So far, we are happy to say that the season has been mild!

### Special Assessment Did Not Pass

The Special Assessment Meeting took place on November 12, 2011, after the Annual Meeting and Elections. The goal of the Special Assessment was to replenish our reserves so that we would have enough money to cover any unforeseen future road expenses.

To pass a special assessment, 51 percent of the membership in good standing is required to vote in favor of it.

For the \$30 assessment, 54 percent of those in good standing voted, and of those votes, 75 percent were in favor of it. For the \$90 assessment, 61 percent of those in good standing voted, and of those votes, 70 percent were in favor. But there were not enough "yes" votes in either case to meet the overall 51 percent requirement.

Since the Special Assessment did not pass, the GLA would welcome any voluntary contribution that landowners may choose to make toward a savings fund for emergency road work in the future. Please contact the Treasurer, Sheridan Stenberg, at 333-4589 if you wish to make a contribution.

### **HOA Management Trial Period**

The Board is pleased to announce its decision to employ a professional homeowner association management company to handle administrative duties for the GLA with this costing no more than is already being allocated for these types of duties currently being performed by contractors.

After thoroughly analyzing our needs and the expenses required to carry out administrative functions, and the options available to handle them, the Board voted unanimously to begin a 6-month trial period, which started in June, with Minnick Management, an HOA management company located in Bozeman. Minnick will handle a wide variety of tasks that range from taking meeting minutes, performing accounting functions, conducting project reviews, to serving as a communication hub, just to name a few. Put simply, Minnick will serve as the administrative branch of the association under the direction and supervision of the Board.

Over the years, the Board has been handling the many administrative tasks necessary for operation of the association to the best of its ability by using both volunteers and paid contractors. This approach has worked fairly well, but at times has been lacking due to the unavailability of contractors, and skilled volunteer resources.

As we have now reached a point where our processes have been better clarified and simplified, we are ready to move to a more professional level of administration. This will enable the Board to better serve landowners by providing a higher degree of consistency and efficiency.

Starting mid-July, all communication with the association will be received by Minnick Management, who will process items as required, including forwarding some things to the director or committee most appropriate to handle it. Our new address and contact information are as follows:

### **Assessment Payment Policies**

The financial health of the association is an important concern of the Board. As part of our streamlining process, the Board has carefully reviewed Section 11 of the Covenants regarding how assessments are to be paid. Starting in January 2013, please be prepared to pay your assessments in the following manner, unless you have established other arrangements with the Treasurer:

Mid-January: Annual assessment statements are sent out to landowners.

Landowners choose 1 of 2 payment options:

- 1) Pay in full by the end of January, or
- Pay in equal quarterly payments by January 31, April 31, July 31, and October 31.

As stated in the Covenants, there is a 30-day grace period for payments, after which a 5 percent penalty and 1.5 percent monthly interest will begin to accrue.

### **Board Meetings Streamlined**

After exploring ways to conduct our board meeting business as efficiently as possible, the Board has determined that items on our agenda must be thoroughly reviewed and/or researched by committee prior to the meeting. This will allow the Board to have the most complete understanding of a subject at the time it is brought before them, thereby allowing meaningful discussion and the ability to make decisions and take actions as needed.

If you have an issue you wish to bring to the Board, please provide us with complete details so that your request can be forwarded to the appropriate Director. After committee research, review and/or necessary preliminary meetings regarding the subject, the item may be placed on the agenda.

Although this is a most unfortunate situation, State law requires that the Association defend itself via legal counsel because of its status as a corporation.

Regarding the first case that has been appealed, briefs have been filed with the Supreme Court by both parties, and we are awaiting the Justice's decision. In the other matter, settlement options are being considered by the Board.

Voting has been done this way since the GLA's inception, and is consistent with voting practices among many other corporations.

### Assessment Payment Policy

As mentioned in our July 2012 Newsletter, starting in January 2013, assessments are to be paid in the following manner in order to be in strict compliance with the Covenants:

- 1) Paid in full by the end of January, or
- Paid in equal quarterly payments by January 31, April 31, July 31, and October 31.

As stated in the Covenants, there is a 30-day grace period for payments, after which a 5 percent penalty and 1.5 percent monthly interest will begin to accrue.

To ensure that the timing of how assessments are to be paid is clear and the consequences when they are not paid, we have enclosed an assessment payment policy for your review.

### **Guesthouse Assessment**

The Covenants state that an assessment is charged for each division of land and for each dwelling unit (11.03), and the association has been charging assessments accordingly to the best of its ability.

Since guesthouses fulfill the description of a dwelling unit (3.12), and the Covenants do not base assessments on usage (nor is the association able to monitor such a thing), the board has determined that guesthouses are to be assessed as dwelling units. Landowners with guesthouses will see this reflected on their January 2013 statements.

Exciting news! We are now set up with our VoiceNation PBX Assistant service to provide timely road condition reports during snowstorms, as well as meeting date announcements for those who wish to call in.

### Road Survey - Landowners Give Input

This past April the Road Committee created a survey that was sent out to all Landowners in order to receive feedback regarding road maintenance, possible ways to improve snow removal and sanding services, options to improve the overall quality of our roads, how to allocate road funds, and how increased services might be paid for.

Thank-you to everyone who took the time to respond!

A total of 165 surveys were received out of the 396 tracts of record in North and South Glastonbury, representing 41.7 percent of the Landowners. 59 Landowners provided informative and thoughtful written comments. Additional responses are still encouraged, so if you have any ideas for the Road Committee, write them up and send them in!

Road Committee members have put substantial attention into summarizing, reading and understanding your input. These responses provide credible guidance for the Board's decisions going forward. Overall the message we get is: 1) maintain the status quo; 2) improve but do not overhaul the winter sanding operation; 3) provide more gravel/grading where it is needed; 4) do not raise assessments; 5) prioritize putting available funds into savings; and 6) continue being fiscally and operationally conservative. We are putting on our creative problem solving hats and devising ways to effectively do these things.

We ask you to do your part. Excess speed, jackrabbit starts and fast stops cause significant damage to our roads. Please drive slowly which will take no more than a few extra minutes getting out to the highway. Our roads and your nervous system will love you for it!

### Your Input Needed on Governing Documents

Do you have ideas on how we can improve our Covenants and Master Plan? The Board would like your input no later than Sept. 1st on possible amendments to distribute to the membership for a vote. Please submit your ideas in writing to Minnick Mgmt.

### Eyesores, Nuisances and Refuse Disposal

Each property owner is responsible to maintain their property in accordance with the Covenants. This is a reminder for those who may not be aware, Covenant 5.04 states: "All refuse, rubbish, trash, garbage and waste shall be kept, disposed of or regularly removed in a sanitary manner. Refuse shall not be allowed to accumulate so as to cause odor or unsightliness." And Covenant 5.05 regarding nuisances and eyesores states: "...the following conditions shall not be allowed.... Abandoned trailers, mobile homes and other structures, junk (inoperative or unregistered) cars and equipment, scrap piles, brush piles, etc...."

Landowners are encouraged to voluntarily remedy unsightly or non-compliant conditions on their property prior to the Board having to take action, which can be costly to both the association and the offending landowner.

### **Building Projects Require Board Review**

Our Covenants require that a project review application be submitted to the Board prior to beginning construction. This allows the Board to ensure that the standards outlined in the Covenants and Master Plan are being followed such as setbacks and building height, and to conduct the variance process when needed. In order to have time to properly review your project, please submit plans at least 2 weeks prior to the monthly board meeting. Forms and instructions may be found on the GLA website under the link, "Applications for New Structures."

### Lawsuit Update

There are currently 3 lawsuits pending against the association filed by Daniel and Valery O'Connell. The first lawsuit was initially dismissed by the District Court and the O'Connells ordered to pay attorney costs and fees. After appealing to the Supreme Court, the O'Connells were asked to re-submit their claim to the District Court, which is currently in process.

The other 2 lawsuits (now being covered by our professional liability insurance) pertain to the following issues: 1) Minnick Management being hired as an agent; 2) the Erickson's variance project; 3) Guesthouses being assessed as dwelling units; and 4) voting practices. The court has granted summary judgment in favor of the Association on all of these issues, and the O'Connells have appealed to the Supreme Court.
