PROPOSED ORDER CHANGING VENUE**


15 The above named Defendants Glastonbury Landowners Association, Inc. Board of Directors, by  
16 and through their counsel of record, submit the attached proposed Order Changing Venue from the  
17 Montana Eighteenth Judicial District Court (Gallatin County) to the Montana Sixth Judicial District  
18 Court (Park County) as the parties now agree that venue should be moved to Park County.

19 Plaintiffs Daniel and Valery O'Connell filed a "Notice Resolving Venue Change" on December  
20 4, 2012. Plaintiffs maintain venue is proper in both Gallatin and Park Counties, but agreed to the change  
21 of venue in order to "save litigation time and expense for all parties by consolidating" this action with a  
22 pending action in Park County which involved the same parties. (Pl.'s Notice Resolving Venue Change  
23 at 1, Dec. 4, 2012). One of the reasons Defendants argued for the venue change was in the furtherance  
24 of judicial economy due to the parallel actions in Park County. The attached proposed Order changes  
25 venue on the grounds of agreement of the parties that a change of venue is proper.


