## **FACTUAL BRIEF**

Recently ten (10) out of 12 of these GLA Board of Directors were removed by members or else quit the GLA Board since the amended complaint filed last year. There are now 10 new GLA Directors that were not a party to this complaint. However, GLA Defendant pleadings and the GLA Board Directors have recently disputed wether any GLA Directors were ever party to this complaint.

All Complaint pleadings and captions such as the one above read, Defendants in this case are the "Glastonbury Landowners Association Inc." and "GLA Board of Directors." Since the time this case was filed 2011, all Plaintiff pleadings and captions for this case obviously name and make it clear that the "GLA Board of Directors" are defendants in this case. And when the complaint was amended March 2013, these same Directors were on the Board and party to this complaint, namely Richard Bolen, Alyssa Allen, Laura Boise, William Smith, Sheridan Stenburg, Gerald Dubiel, Paul Rantallo, Rich Spallone, Janet Naclerio (excluding Neil Kramer & Claire Parker that quit the Board in 2011).

These complaint pleadings are overwhelming evidence that these specifically named "GLA Board of Directors" are defendants in this case.
